shared goals.

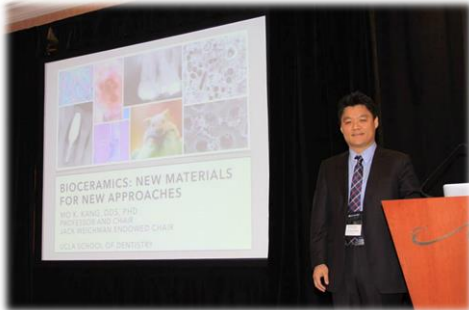

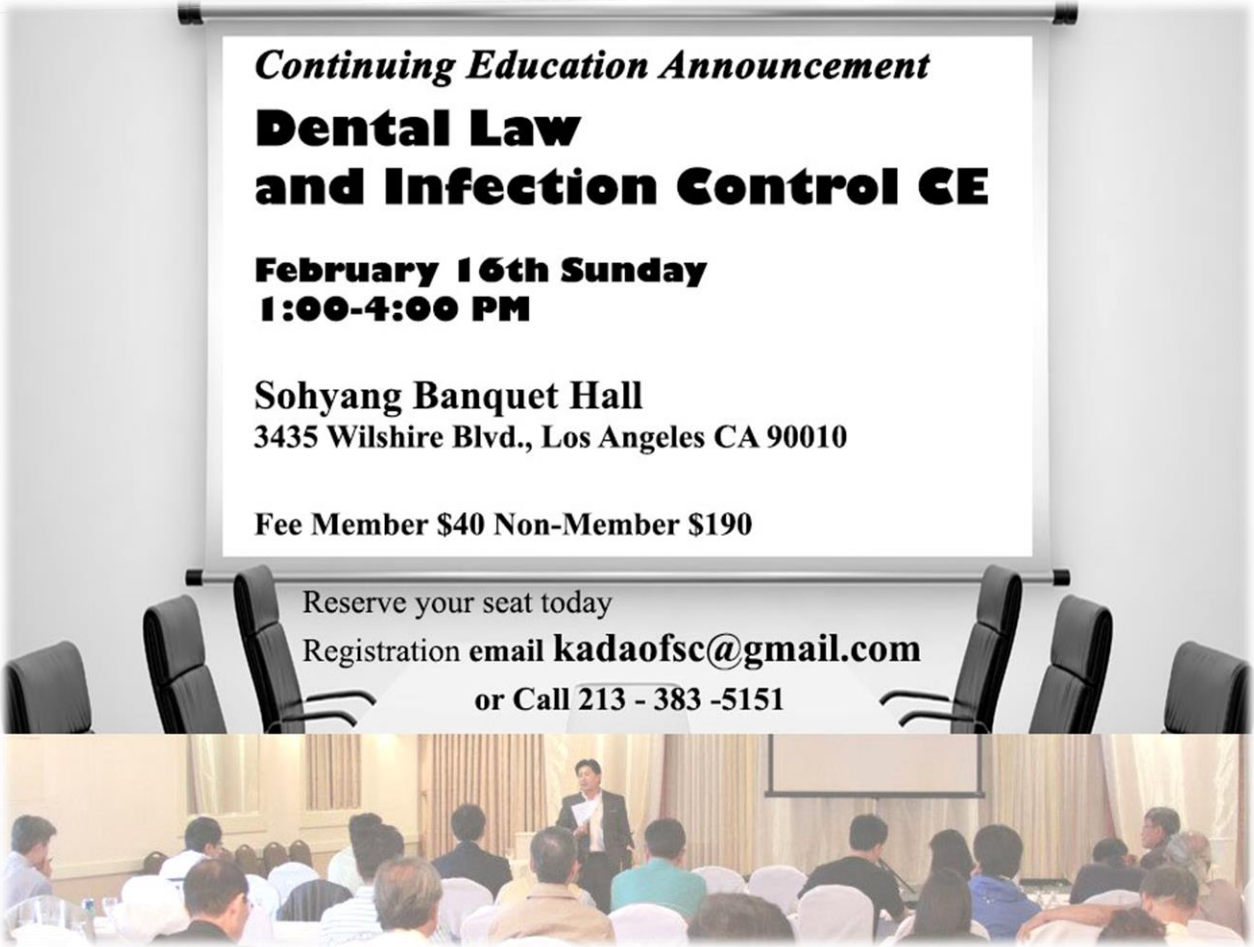

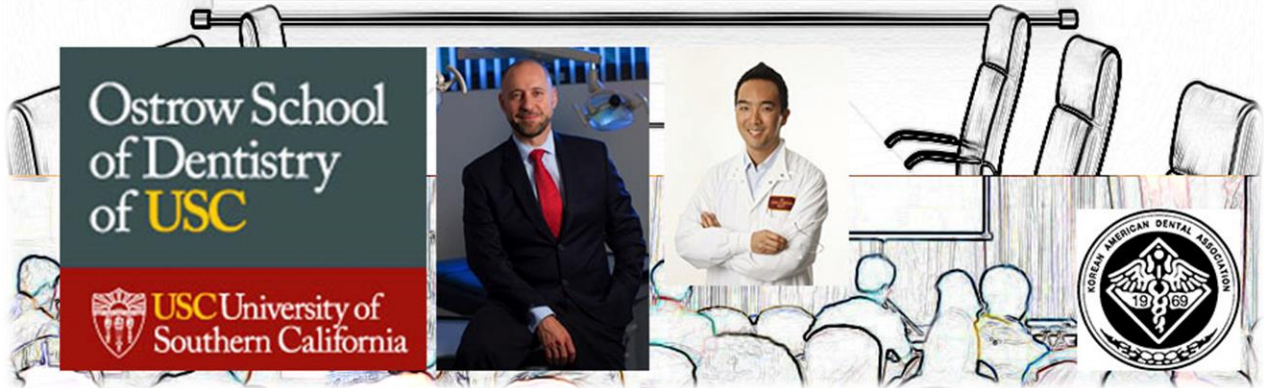
